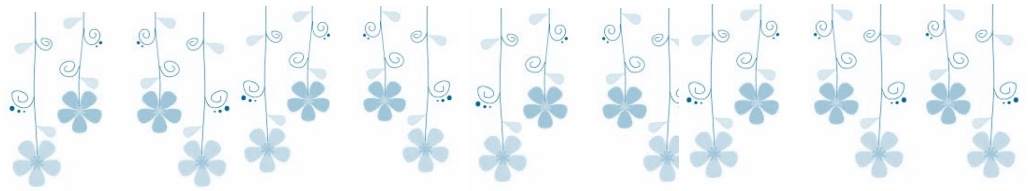

Inner City Woman's Health Care Nurse Practitioner To Speak on Affordable Care Act at Santori Library

Although some members of the US Congress are determined to overturn it, the Affordable Care Act has made some very positive impacts on the lives of women living in Chicago's inner city, according to Lorelei Beyer.

Beyer is a woman's health nurse practitioner and midwife who has a bachelor's degree in nursing, a master's degree in nursing and midwifery and certification in nurse midwifery. She will be speaking on two topics, "The Impact of the Affordable Care Act, and Midwifery Today," at 6:30 p.m. Wednesday, March 16, at the new Santori Public Library, 101 S. River St., Aurora. The discussion is free and open to the public. A short PowerPoint depicting key areas of the new library also will be shown.

State Rep. Linda Chapa LaVia (D 38th District) and the Aurora Chapter of the American Association of University Women are co-sponsoring the discussion, which is being hosted by the Santori Library.

With 37 years experience in nursing, Beyer has worked in both suburbia and the inner city. She spent 34 of those years at South Suburban Hospital, then went to the University of Illinois, Little Company of Mary Hospital, taught nursing students at St. Xavier University and most recently has been working as a midwife and woman's health practitioner out of Mercy Hospital, 25th and Michigan Avenue in Chicago. Mercy, founded by Mother McCauley, was the first hospital established in Chicago.

"I can speak on the Affordable Care Act's impact on my patients because I see it every day," said Beyer, who as a certified nurse practitioner can prescribe medications for her patients. "My patient population is lower socioeconomic women who rely strongly on Medicaid and Medicare. Many of these women were without well-woman care until the Affordable Care Act was passed. So I have seen what a difference it's made."

That doesn't mean that the Act is perfect, Beyer said. In her talk, she plans to discuss ways it can be improved to better serve everyone.

As for midwifery, Beyer says this type of care is making a comeback and midwife nurses are currently being licensed by the State of Illinois. Midwives, she said, are not physicians, but neither are they assistants. They are considered mid-level providers.

"Our role is growing," she said. "The emphasis is now on keeping people well, keeping them healthy, and keeping them out of hospitals. Most of my practice is in well-woman care. There is a huge need for such practices.

The meeting was called to order at 9:08 a.m. by Sandy Hipp. The minutes of the August 15, 2015, meeting were approved following a motion moved by Andi Danis and seconded by Elaine.

Our Treasurer, Pat Daugherty, and Assistant Treasurer, Julie Bauman, will give their respective reports at our January meeting.

Andi Danis reported that our Opening Meeting in September meeting went well. We also have a possibility of using the public library without charges for our March event. Before January we look forward to:

November 18, 2015, Book Discussion: What Will It Take to Make a Woman President by Marianne Schnell, The Turf Room, North Aurora at 5:30 p.m.

December 6, 2015, Holiday Social Event: The Lueth House followed by the A.U. Holiday Concert, The Lueth Residence and Aurora University at 4:30 (Social) and 7:30 (Concert).

Membership held a Prospective Member Open House on September 30, 2015. The event went very well. Jo Howard and Tracy Sherman have become new members while five potential new members have been identified and will be recruited individually.

Vicki Peterson, VP for Communications, reported that we have 10 Facebook members and a number of likes. Membership is encouraged to follow AAUW's Facebook page.

Although Jane Zimmerman was unable to attend the meeting, she reported on the financial success of the AAUW Funds Fall Wine Event held on October 17, 2015. An amount of \$1854 was collected; expenses totaled \$215.97 which left a profit of \$1638.03. Individual donors as well as the branch need to be recognized by our National AAUW. A good time was had by 34 participants. Udo Igwe, Linda Chapa LaVia, and Stephanie Kifowit are all winners in their own right, but also took home prizes that evening.

The Books by Night group will be meeting at 7:00 p.m. on October 28, 2015, at Ballydoyle Irish Pub; the book for October is *All the Light We Cannot See*. The movie group will be meeting on November 9, 2015, at the home of Denise Curts-Lueth and is viewing *MIGHTY MAC'S*.

We received a thank-you from Paula Sabotta who was honored at the first meeting of the 2015-2016 year for her 50 years of membership in AAUW.

Udho Igwe has retired from being the editor of our Branch's newsletter. Her consistent and excellent work have been appreciate by us all. Jerre Henriksen will take over that duty, but we will reduce the monthly newsletter to Fall, Winter, Spring, and Summer editions. Articles for the Winter edition are due on November 23, 2015.

Sandy Hipp announced that the event, Keeping the Mind Sharp, will be held on November 5th at the Prisco Community Center between 11:00 a.m. and 2:00 p.m.

Andi Danis reported that between the Women's Power Lunch on September 17, 2015, and the Mutual Ground Walk on October 18, 2015, \$98,000 was raised to support the work of Mutual Ground.

The Fall AAAUW District Conference was well done. Andi Danis attended and praised the updates and breakout events. Andi informed us of requirements regarding AAUW bylaws at the local, state and national levels. The following formal, but shortened for convenience, statement from our AAUW web site indicates the basic facts involved.

"The 2015 AAUW bylaw amendments voted on and approved by the membership require mandatory revisions of all state and branch bylaws to conform these bylaws to those of AAUW. The IRS-approved contract between each AAUW state and branch and AAUW national, stipulates that states and branches must conform to AAUW bylaws in all material respects. By May 15, 2016, all branch and state presidents must submit their bylaws electronically to AAUW via connect@aauw.org to be maintained at national headquarters as required by the IRS."

Andi will send our book with our By-Laws which meet the requirements.

Co-presidents. Elaine Ross and Sandy Hipp, with Jane Zimmerman will designate our National AAUW Donations.

Announcement included a December 5, 2015, event in honor of Jane Adams. The Aurora Actionnaires will be holding an annual fundraising event on November 14. The cost of attendance is \$60 and a Motown style band will play.

The next board meeting will be at 9:00 a.m. on January 23, 2016, at the Harris bank. The remaining meetings for 2015-2016 to be held at 9:00 a.m. are: March 19 and June 25.
