Public Policy Report

Just a Few Comments on Issues of Public Policy

The summer months have not been very active regarding legislative initiatives on the Illinois or National levels. Legislative reports are sparse up to September, but there are a few things to celebrate and some for which we must continue our activism and support:

<u>Illinois</u>

As you know, the **Reproductive Health Act** (SB2495) passed out of both the House and Senate and was signed into law by Governor Pritzker. The law is now clear in Illinois: decisions about reproductive health care are between patients, their family members, doctors, and other health care providers.

Now we must continue our activism to help in the Passing the SB 1594 **Parent Notice of Abortions**— **Repeal**. This initiative is strongly supported by AAUW, but is still languishing in committee and did not pass in the General Assembly before its summer adjournment. Let's continue to send our support via the **Two-Minute Activist** site and via calls and emails to our legislators.

The **Equal Pay Wage History bill** (HB 834) passed both the House and Senate after years of efforts for its passage. Illinois successfully updated its law so that now there is a ban on using a person's salary history in the hiring process. This history was a way that employers could use past pay history that would further widen the pay gap that often exists for women.

Ensuring Success in School (SB 449) has passed in both the Senate and House Education Committees, but needs a full vote now on the House floor. Those who voted "yes" on the Equal Pay Wage History bill are expected to vote "yes" on this bill when it comes up. The bill addresses issues that affect students who are pregnant or who have been victims of gender-based violence by enhancing their school safety. It also takes the courts out of the processes of addressing excused absences, student confidentiality, and school transfers of students.

Here is something I heard yesterday on NPR: Governor Pritzker signed the **bi-partisan bill that will extend insurance coverage for mammogram tests**. The issue was that insurance companies were not required to cover more than the initial test itself; now companies must also cover follow-up mammograms and other tests that relate to breast health. Look for further information on this new law in Illinois.

Washington, DC

The news is not so encouraging on the national level. While the House continues to pass legislation that would further issues of paycheck fairness, closing the wage gap, voting rights, STEM education for girls, Black Women's Equal Pay, and more, none of these, so far, has passed through the Senate, and probably will not pass or be signed into law. Still, AAUW always informs you through "AAUW Washington Update" on the issues being worked on and ways you can be heard. AAUW also has expressed its grave concern about the rollbacks concerning Title IX under Betsy DeVos and the Department of Education. Try to read the statement from Kimberly Churches on the national website entitled "AAUW Responds to Department of Education Title IX Announcement" to learn more on this issue. Also, posted on the website are the biennial priorities of AAUW, entitled "AAUW Public Policy Priorities," that were adopted in May 2019. The document is long but highly informative regarding the directions that our organization wants to take in the near future.

There are many legislative initiatives we still need to keep following through emails and websites. Try to always read the **In the Statehouse** and the **Washington Update** postings, and use the **AAUW Action Network** and the **Two-Minute Activist Tool** to take action when you can. Let's all try to stay informed and active when we gear up for the fall and for the work that lies ahead in furthering equity for women and girls.

Minutes for AAUW Board Meeting of January 26, 2019 at 9:00 a.m. Harris Bank, Orchard Road

In attendance: Tracey Sherman-Falcon, Nicole Benziger, Valerie Burd, Andi Danis, Pat Daugherty, Jerre Henriksen, Vicki Petersen, Elaine Ross, Kathy Schultz

The meeting was called to order by President Tracy Sherman-Falcon at 9:10 a.m.

Minutes from the previous meeting of October 27 were read and corrected (Vicki Petersen was listed as present, but then (later) as absent), and were approved as corrected. Andi D. made the motion; Jerre H. seconded it.

- <u>Programs</u>: Chair Valerie B. reviewed the progress for the Chili Supper of February 20 and the needs for the speaker. Vicki P. mentioned a new digital program, "Sign-up Genius," which might be used for future reservations; some drawbacks for this method of responding, however, were noted.
- Valerie B. mentioned a possible speaker for a program next year, Ann Moore of the Changing Children's World Foundation. Valerie said she will invite her to come to our Chili Supper.
- The April program was discussed briefly. Valerie noted that the program, "What You Can Do for Our Environment," will be presented in conjunction with Green Connect of Yorkville, a Chamber of Commerce member. Ticket price will be \$20.00, with a free lunch for the two presenters.
- Tracey S-F mentioned a possible presenter for next year whom she met through the Latina Mastery Institute. Her topic would be "Do You Have Enough Time?"
- Finally, it was approved (by acclimation) that a stipend of \$25.00 be given to the three presenters (AAUW Scholarship speakers for the May meeting).
- <u>Membership</u>: Kathy S. said that she did not have an "official" report. She did, however, give the total of our current membership, 37; Mae Smith is a new member; Lisa Wolancevich and her daughter may become members; and there may be one other new member whom Kathy has suggested.
- <u>Communications</u>: Nicole B. reported that she is updating our Branch's website and working on a logo for the 100th Anniversary Celebration. Tracey S-F suggested that we take a photo at our events *before* the event begins so that we manage to get all attendees in the photo (some people leave early or just disperse). Nicole said that we have 54 members on our public Facebook page and 18 on the private page.

<u>Treasurer</u>: Andi D. reported that our general balance is \$2,623.03.

- <u>Assistant Treasurer</u>: Vicki P. reported that the balance in our EF and LAF funds is \$944.28. The namedgift contribution for the AAUW funds will be made in honor of Valerie Burd for all her efforts and successes in programs and securing donations from businesses.
- <u>Newsletter Editor</u>: The Spring Newsletter will be out just before our April I9 Branch meeting. The deadline for submissions will be **March 22**!
- <u>AAUW Funds</u>: Pat D. reported on the Bunco Fundraiser event in November, and Tracey explored what we might do to get more members to attend such events.

AAUW Branch Minutes ——Continued

- <u>Public Policy</u>: Elaine R. did not have a formal report but discussed several issues of concern (still!) to our Branch and AAUW Organization. She focused on the restrictions now in effect in certain states regarding reproductive rights or now in litigation in the courts, especially the proposed lifting of even more strictures on employers' requirement to cover birth control access. She shared a special section of the *NYT* on how women are increasingly being arrested, tried, and imprisoned on spurious charges resulting from their pregnancies, stillbirths, deliveries, or gestational periods. Nicole B. mentioned an event, Giving Tuesday, sponsored by the YMCA, saying that perhaps we, as a branch, could piggyback upon this. Tracey S-F told everyone about an event to occur in Springfield on May 15, sponsored by Planned Parenthood on May 15, which will be a Lobbying Day concerning women's reproductive rights.
- Social Chair: Joy B's report was submitted in advance online.

The positions to be filled for the upcoming term are Programs, Membership, and Treasurer. Valerie volunteered to take VP for Membership; Andi said she would continue as Treasurer; that left only VP for Programs. The committee from last year was Penny C., Jerre H., and Elaine R., so they continue this year to put forward nominations. Elaine asked for ideas about nominees from the Board. The slate of nominees must be presented to the Board in April and in the spring newsletter for the branch, to be voted on at the general May meeting.

- <u>Study Groups</u>: Andi D. updated everyone on Books by Night, and Elaine updated everyone on Movie Study Group. Andi strongly stated that everyone should read *The Woman Who Smashed Codes* by Jason Fagone.
- <u>100th Anniversary Celebration</u>: Andi brought everyone up to date re/ what is next in the planning for the event to take place on September 21. The next meeting is set for 2/7 at Colonial at 9:00 a. m. <u>Lunafest</u>: Tracey gave a rundown about the upcoming Lunafest events in the area. A discussion took place about our Branch's participating in the Oswego event to be on 2/9/19 from 3-6:00 p. m. One-half of the proceeds go to Breast Cancer research and treatment and one-half to the sponsoring organization. Tracey will send out an email alerting everyone to the event.

Adjournment: The meeting was adjourned at 10:30 a.m.

- <u>Programs</u>: Jerre H. reported for Valerie B. The event for Saturday, 3/16/19 at the GAR building in Aurora, "Women of World War II: On the Front Lines and the Home Front," was discussed. The question of whether it would be worthwhile for our branch to pay the membership fee to join a Chamber of Commerce was explored. Yorkville's fee is \$100.00, but Aurora is no doubt higher. It was decided that Andi D. will investigate the costs and benefits. Tracey will handle the refreshments for the 3/16 meeting. It was asked whether we can have a membership table at the March 16 meeting, and everyone thought we could. It was also discussed as to how the promotion for this event had been handled; the GAR members do not seem to be promoting us as part of the event.
- Two of the three speakers for our May 11 meeting have confirmed.
- <u>Membership</u>: Tracey S-F., reporting for Kathy S., discussed taking the online Work Smart program. She said that we should go the site and register for it. Fliers will be available on this at our next meeting. Andi D. said that the Gender Equity Fund Board (State) had met and that it is encouraging us to take this training program. It was suggested that we could have a computer room in a place that all can share to take the training, perhaps at the main Library. Tracey will reach out to Krista D. at the Library. This event must take place before August; maybe this can be in June or even at the March or April meeting. Nicole, Andi, and Pat will work on this.
- <u>Communications</u>: Nicole B. updated us on what she has done for our upcoming 100th Anniversary Celebration. She will have our front page up on the website by 5/15 and other pages perhaps. The event will also be promoted with posts on Facebook. Nicole mentioned that no word has come yet about the winners of the Art contest.
- <u>Treasurer</u>: Andi D. gave us the good news that the IRS has finally solidified our status as "tax exempt." We were reinstated retroactively to 11/15/2012. Now that we have a tax-exempt number, giving us independent status from our affiliate, we can use it for direct tax exemptions for members and events. Andi D. will send directly the \$25.00 memorial gift for Mary Bernard, and she will also ask to have her removed from membership in the state directory. Tracey will send the memorial report for the State Convention booklet. Pat suggested that we put an item in our next newsletter about Mary B.
- The balance reported (Treasurer's Account) was \$2,623.03.
- Assistant Treasurer: Vicki P. reported that there has been no change since her last report; the balance for EF and LAF is \$944.28.
- <u>Newsletter</u>: Jerre H. is staying with the date stated in our last meeting, March 22, as the deadline for items for the spring newsletter.

- <u>AAUW Funds</u>: Pat D. said she is concerned about what we can do for our next fundraiser (in the fall of 2019). After much discussion, we decided that we will "let up on ourselves" since we are having the 100th Anniversary Celebration also in the fall. Instead of an event, we will just have a Virtual Fundraiser. The idea was mentioned that we could piggyback on Giving Tuesday for this "fundraiser." Other ideas were explored: a Birthday Fundraiser through FB or an Amazon Smile Account, which is easy to set up, according to Nicole B. Further work will be done on how to do this virtual "fundraiser."
- <u>Public Policy</u>: Elaine R. will follow up on asking branch members to show their support for HB 2495, the Illinois Reproductive Health Act, and SB 1594, Repeal of the Illinois Parental Notice of Abortion Act. She will send an emailed letter as well as ask for members to use an emailed template for a letter to their newspaper editor to express their support for these bills. A long discussion followed on today's political scene.
- Tracey S.-F. inquired about how we will handle the logistics of the upcoming Lobby Day in Springfield on 5/15. For example, there is a limit on the number of those who can go.
- Social Chair: Joy B. submitted her report ahead of the meeting since she could not attend.
- <u>Nominations</u>: Elaine R. reported on her difficulty in getting anyone to agree to be nominated for VP for Programs. A long discussion followed. Elaine will send an email, through Jerre H., that will explain that we may not have a VP for Programs for the coming year. Ways to have programs without a VP were discussed. We agreed that we will drop the Chili Supper (attendance and participation for the last one were a disappointment); we could also drop an event for the Christmas Holidays; we could have the Book and Movie groups do one program each; and, as a last idea, Elaine suggested that she and Andi could do one program as a travelogue covering their upcoming Seneca Falls and Women's History Trip with the Rockford Branch. Also, the first and last meetings of the year are already somewhat determined as general meetings.
- Tracey discussed her frustrations with the activism of our branch members, giving examples of those who do not even engage with the Two-Minute Activist or Witness Slips for legislation. Tracey will forward information she has received on Operation Equity.
- The upcoming book for Books By Night was announced and the upcoming movie for Movie Study Group, *First Women* by K. A. Brower and *Megan Leavey*, respectively.
- Andi D. announced that the next meeting on the 100th Anniversary Celebration will be April 25 at Colonial in the a.m.

Andi D. announced details about the upcoming Mutual Ground Gala on April 26.

The meeting was adjourned at about 11:05 a.m.
